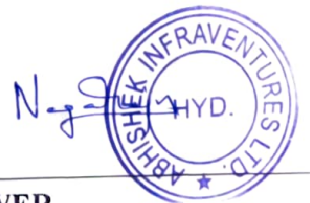

Summary Proceedings of the Meeting:

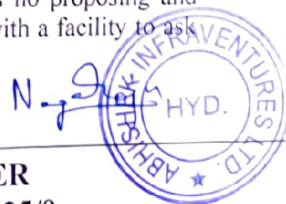
